# Quarterly Report 30th June 2015

## **Corporate**

## **Completion of Merger Process**

Following the Federal Court and Trafford Resources Limited ("Trafford") shareholder approval, the merger of IronClad Mining Limited ("IronClad") (ASX:IFE) and Trafford became effective on Wednesday 6 May 2015.

The Board has decided to reflect the fresh beginning created by the merger with a new name: **Tyranna Resources Limited**. The proposed name change, together with a number of other administrative matters, will be put to shareholders at a meeting on the 29th of July, 2015.

IronClad's Chairman, Mr. Ian Finch said "We are excited to be starting a new phase of corporate development and look forward to reporting to shareholders throughout the year about the progress achieved in taking IronClad into a producing gold company"

#### IronClad Shares and Options on issue

Following the merger IronClad has 236,857,050 shares on issue and 25,700,846 listed options exercisable at 20 cents on or before 20th May 2016. Subject to shareholder approval 28,775,445 shares held by Trafford Resources will be cancelled within the current financial year.

In June 2015, IronClad issued to financiers in part consideration for \$600,000 loans a total of 10,000,000 options exercisable at 3 cents within 3 years of issue and 2,000,000 options also exercisable at 3 cents within 2 years of issue.

#### The Board

The Board of IronClad will remain unchanged and Mr. McKay remains the Company Secretary.

#### Securities Exchange Listing

IronClad will continue trading on ASX under the code IFE. However, should shareholders approve the name change to Tyranna Resources Limited then the new ASX code ("TYX") will be used.

#### Mining Lease Environmental Bond

During the quarter, rehabilitation of mining related infrastructure at the Wilcherry Hill Project resulted in the release of the \$300,000 environmental bond to the company held by the South Australian Government over the Mining Lease.

## Orinoco Gold - Underground Mine Development Commences at Orinoco's Cascavel Gold Project

In this quarter Orinoco Gold Limited (ASX:OGX) informed the market that its Board has formally approved the commencement of underground mine development at its high grade Cascavel Gold Project in Central Brazil.

This decision follows the successful completion of due diligence by Chancery Asset Management – a Singapore based, private mining investment company, clearing the way for the provision of a US\$8 million gold sharing arrangement.

Metallurgical test work in the quarter returned results that demonstrate high gravity gold recoveries of 89% - 95.6% at a coarse grind of 600  $\mu$ m. The recoveries, at a coarse grind size, further highlight the anticipated low cost of gold recovery from the ore.

Orinoco also reported to the market that "Mine development and construction at Cascavel were now in full swing". This includes the development of the incline shaft, the construction of the explosives magazines and warehouse as well as additional site preparation such as the construction of site offices, ROM pad and haulage

IronClad Mining Ltd. currently holds 13,641,447 shares in Orinoco Gold Limited, or approximately 6.73% of Orinoco's issued capital.

#### **Subsequent Events**

In July, the Company announced a \$600,000 capital raising by a placement of \$300,000 to sophisticated investors and a \$300,000 Share Purchase Plan to eligible shareholders.

At a General Meeting of shareholders held on 29<sup>th</sup> July 2015, shareholders approved the Company's change of name to Tyranna Resources Limited (ASX:TYX).
